Regulation 4(1)(a)(b) and 4(2) of the Town and Country Planning (Control of Advertisements) Regulations 1992 states:-

"A local planning authority shall exercise their powers under these Regulations only in the interests of amenity and public safety, taking account of any material factors, and in particular:

- (a) In the case of amenity, the general characteristics of the locality, including the presence of any feature of historic, architectural, cultural or similar interest, disregarding, if they think fit, any advertisement being displayed there;
- (b) In the case of public safety:

- (i) The safety of any person who may use any road, railway, waterway, dock, harbour or aerodrome;
- (ii) Whether any display of advertisements is likely to obscure, or hinder the ready interpretation of, any road traffic sign, railway signal or aid to navigation by water or air.

In determining an application for consent for the display of advertisements, or considering whether to make an order revoking or modifying a consent, the local planning authority may have regard to any material change in circumstances likely to occur within the period for which the consent is required or granted."

OTHER MATERIAL CONSIDERATIONS

It is considered that there are no other material considerations to warrant a decision otherwise than in accordance with the Development Plan and/or legislative background.

CONCLUSIONS

The purpose of the advertisement is to draw the attention of users of the public car park to the presence of a family oriented tourist business in a seaside resort. Since signage in a variety of colours and design is located within the immediate area, the proposed signage is not considered to have an adverse impact on public safety, nor would it be obtrusive in the street scene.

It is therefore recommended that Advertisement Consent should be granted, subject to the conditions set out overleaf.
