- A) 1no. arched main vehicular and pedestrian entrance with halo illumination and external and internal illuminated sections, overall length 10.5m and overall height of 6.5m from the ground to the top of the sign
- B) 1no. arched pedestrian entrance feature with external and internal illuminated sections overall length 4.0m and overall height of 4.6m from the ground to the top of the sign
- C) 14no. banners 1.0m x 5.0m on flag poles each 10.20m in height
- D) 3no. externally illuminated signs mounted of token/ticket sales kiosks overall length 4.4m and overall height of 5.1m from the ground to the top of the signs
- E) 2no. externally illuminated signs mounted on catering/refreshment kiosks overall length 3.9m and overall height of 5.0m from the ground to the top of the signs
- F) 1no. internally illuminated set of letters height of each letter 1.10m and 5.6m from the ground to the top of the lettering
- G) 1no. set of halo illuminated letters height of each letter 0.4m and 3.6m from the ground to the top of the lettering
- H) 1no. set of non-illuminated letters height of each letter 0.15m and 3.2m from the ground to the top of the lettering
- I) 2no. non-illuminated poster plaques 1.40m approx. from the ground to the top of the plaques
- J) 10no. internally illuminated banners 1.0m in length and overall height of 7.0m from the ground to the top of the banners
- K) 7no. externally illuminated signs overall length of each sign 2.8m and overall height of 3.4m from the ground to the top of the signs
- L) 1no. set of internally illuminated letters height of each letter 0.7m and 3.0m from the ground to the top of the letters
- M) 1no. internally illuminated sign 5.4m x 0.5m and 2.7m from the ground to the top of the sign
- N) 1no. externally illuminated sign 5.4m x 0.7m and 3.4m from the ground to the top of the sign
- O) 4no. internally illuminated banners each 0.7m in length and overall height of 4.7m from the ground to the top of the banners
- P) neon illuminated ride theming wall 110m in total length
- Q) neon lighting to existing front elevation of enchanted castle building and front and side elevations of existing megafun building total length 95m, minimum height above ground 2.6m running to 4.0m at the top
- R) neon lighting to front and side elevations of existing gaiety theatre total length 55m, minimum height above ground 3.2m running

to 14.4m at the top, and

S) lno. non-illuminated sign mounted on a kiosk and an archway 3.4m approx. from the ground to the top of the sign.
